I am directed by the Commission to write as under:

In the reference first cited, the Commission had requested Government of India to issue directions under Sections 92/108 of the Andhra Pradesh Reorganisation Act, 2014 to address five issues relating to the orderly and harmonious transition of the existing Andhra Pradesh Electricity Regulatory Commission (APERC) into the successor Commissions of the two States of Andhra Pradesh and Telangana. These issues are:

- (i) Status of Appeals filed by APERC in higher Courts in public interest.
- (ii) Continuation of 41 full time regular staff of this Commission.
- (iii) Obligation of Pension liabilities of this Commission
- (iv) Status of the Chairman and Members of the existing Commission
- (v) Distribution of assets and liabilities of the existing Commission

In the letter second cited, Government of India had requested the Commission to recommend the way forward in each of the five issues raised by the Commission. In the letter third cited, the Commission had given its specific recommendations to Government of India on the way forward on each of these issues to the Government of India.

In the letter fifth cited, the Government of India was informed that the Government Andhra Pradesh had appointed Sri Justice Bhavani Prasad, as Chairman of the Andhra Pradesh Electricity Regulatory Commission in the G.O. 4th cited.

Government of Telangana have in G.O.Ms.No.13 dated 22.10.2014 appointed Chairman and Members of the Telangana Electricity Regulatory Commission (copy enclosed).

This Commission had foreseen this situation in April, 2014 and has been continuously requesting since then (vide our Advisory No.1 to the then Government of Andhra Pradesh and subsequent Advisories No.2 & 3) that steps be taken for an orderly and harmonious transition of the Regulatory Commission as well as the Power Sector to the two successor States. However, these issues are yet to be addressed.

As on date, three Regulatory Commissions are in existence. These are (1) the Regulatory Commission for the State of Andhra Pradesh; (2) the Regulatory Commission for the State of Telangana; (3) and this Commission. Due to this turn of events, this Commission has been placed in a highly anomalous position where neither has it been legally dissolved nor does it exercise any jurisdictional authority.

Considering this amorphous situation, the Chairman and Members of this Commission are constrained to recuse themselves from office with immediate effect without prejudice to their rights.

The Commission Secretary has been delegated the responsibility to undertake the routine work of the Commission until orders are issued on the five transitional issues outlined above.

Government of India is once again requested to take a final view on these five transitional issues under Section 92/108 of the A.P. Reorganisation Act, 2014 and issue suitable directions.
