విషయం - సెస్ సిరిసిల్లా పవర్ లూమ్స్ విద్యుత్ బ్యాక్ బిల్లింగ్ వేసినదానిని ఎత్తివేయడం గురించి.

మా మనవి ఏమనగా మొదటగా మాయొక్క పవర్ లూమ్స్ కు విద్యుత్ మీరు 4వ కేటగిరిలో 25 HP లు చేసినందుకు మీకు దన్యవాదములు కృతజ్ఞతలు

గత 25 సంవత్సరాల నుండి మాయొక్క పవర్ లూమ్ పరిశ్రమలు చిన్న కుటీర పరిశ్రమలుగా ఏర్పడి మేము పవర్ లూమ్స్ నడుపుతూ జీవనోపాధి పొందుతున్నాము. మా యొక్క వ్యాపారములలో లాభనష్టాలను మేమే భరించుకుంటున్నాము. మాయొక్క స్థితిగతులను గమనించి ఎంతో మంది పవర్ లూమ్ కార్మికుల ఆత్మహత్యల తర్వాత ప్రభుత్వం మాకు పవర్ లూమ్ పరిశ్రమై ఉన్నటువంటి విద్యుత్ సరఫరాను 4వ కేటగిరి లోకి మార్చి సబ్సిడీ ఇవ్వడం జరిగింది. ఇట్టి విద్యుత్ సబ్సిడీ 10 HP వరకు మాత్రమే ఇచ్చినది. కాలక్రమేణా కార్మికునికి వేతనం సరిగ్గా రాక జీవించడం కష్టమైన తరుణంలో మేము కొన్ని పవర్ లూమ్స్ పెంచుకోని కార్మికునికి హెచ్చింపు వేతనం వచ్చే విధంగా మరియు కార్మికుల జీవన విధానం మెరుగుకొరకై పవర్ లూమ్లను పెంచుకోవడం జరిగింది. ఆ క్రమములోనే విద్యుత్ ను వాడుకోవడం జరిగినది. దానికి స్థానికంగా ఉన్నటువంటి సెస్ విద్యుత్ సంస్థ మరియు రాష్ట్ర ప్రభుత్వం కూడా సహకరించి విద్యుత్ సబ్సిడీ 50% ఇవ్వడం జరిగింది.

అదే ప్రకారం మాయొక్క పవర్ లూమ్ వ్యాపారం నడుస్తున్న క్రమములో ప్రభుత్వం బతుకమ్మ చీరల ఆర్డర్ ఇచ్చినది కానీ ఆర్డర్ లో కొన్ని ఇబ్బందుల కారణంగా ఎస్.ఎస్.ఐ. యూనిట్స్ గా ప్రభుత్వ సలహా మేరకు మారాల్సి వచ్చింది. మేము ఎస్.ఎస్.ఐ. యూనిట్స్ 2016/2017/2018/2019/వరకు 127 యూనిట్స్ గా ఏర్పాటు చేసుకున్నాము. మేము 30-03-2023 వరకు సెస్ సంస్థ మాకు ఇచ్చిన బిల్లుల ప్రకారం విద్యుత్ బిల్లులు చెల్లించినాము. ఆ తర్వాత మాకు తెలియకుండానే మేము చెల్లించిన బిల్స్ పైన బ్యాక్ బిల్లింగ్ వేసి బిల్స్ చెల్లించాలని సెస్ విద్యుత్ అధికారులు ఇబ్బంది పెట్టుతున్నారు. ఇట్టి బిల్స్ చెల్లించే స్థానం లేక మాయొక్క కుటీర పరిశ్రమలను మూసివేసుకోవడం జరిగింది. పరిశ్రమ మూతపడటం వలన పరిశ్రమపై ఆధారపడిన కార్మికులు అనుబంధ కార్మికులు ఉపాధి కోల్పోయి రోడ్డు పడి, రోజులు గడన కొందరు ఆత్మహత్యలకు పాల్పడినారు.

మీరు నూతనంగా ప్రవేశపెట్టిన 4 వ కేటగిరిలో 25 HP ల విద్యుత్ వాడుకోని పరిశ్రమను పునరుద్ధరించాలని అనుకుంటున్న సమయములో బ్యాక్ బిల్లింగ్ కట్టితేనే మీకు 25 HP వర్తిస్తున్నది అని సెస్ విద్యుత్ అధికారులు చెప్పుచున్నారు. అట్టి బిల్స్ మేము కట్టలేక దిక్కుతోచని స్థితిలో ఉన్నాము. ఈయొక్క పెండింగ్ విద్యుత్ బిల్లు చెల్లించమంటే, పరిశ్రమ మూతపడి, మల్లి కార్మికులు ఉపాధి కోల్పోయి, రోడ్డునపడి ఉపాధిలేక కార్మికుల ఆత్మహత్యల పర్వము మొదలు అయ్యే పరిస్థితి వచ్చే అవకాశం కలదు.

మేము 30-03-23 వరకు సెస్ మాకు ఇచ్చిన బిల్స్ ప్రకారం చెల్లించిన తర్వాత బ్యాక్ బిల్లింగ్ 3 వ కేటగిరిలో వేసి బిల్స్ ఇచ్చినారు. అప్పటివరకు మేము 4వ కేటగిరిలో క్లాత్ తయారుచేసి క్లాత్ పైన మేము మాకు సెస్ ఇచ్చిన 4 వ కేటగిరి బిల్స్ ప్రకారము రేటు క్లాత్ పైన వేసి అమ్మినాము. ప్రభుత్వానికి కూడా బతుకమ్మ చీరలు తయారుచేసి ఇచ్చినాము, మళ్ళీ మేము అమ్మిన క్లాత్ పైన రేటు వేసి తీసుకరాలేని పరిస్థితిని కూడా మీరు గమనించగలరని మనవి.

కావున దయామయులైన మీరు మా యొక్క ఈ సెస్ విద్యుత్ బ్యాక్ బిల్లింగ్ రద్దు చేయించి మా యొక్క పవర్ లూమ్ కుటీర పరిశ్రమను ఆదుకోగలరని సవినయముగా ప్రార్థించుచున్నాము.

Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or directions more particularly one in the nature of Writ of Mandamus, declaring the action of the respondents more particularly the respondent No.6 in issuing Bill-cum Notices to the (127) Small Scale Industries (SSI) power loom units (cottage industries) available in Rajanna Sircilla District, TS under the category of LT-IV(A) since the year 2016 onwards to till this date, even though the said units are falling under the category of LT-III for clubbing of multiple category LT-IV(A) service connections available in the same premises with connected load exceeding 10 HP, without implementing the clause 9.4.3 of the Retail Supply Tariffs and Cross Subsidy Surcharge for Financial Year 2022-23, dated.23-03-2022 issued by the respondent No.3 and even after issuance of letters vide Lr.No. CESS/MD/DE/Com/D No1760/4/2021, dated.05-02- 2022 to the (127) Small Scale

Industries (SSI) power loom units and thereby causing huge financial loss to the Cooperative Electricity Supply Society Ltd(CESS), Sircilla and not recovering the arrears of the bills from the year 2016 onwards to till this date from the (127) Small Scale Industries(SSl) power loom units (cottage industries) as per the existing tariff orders and not considering the petitioner's representations dated.16-08-2021, 13-08-2021 and 19-08-2020 by the respondents, to till this date , as highly illegal, bad in law, arbitrary and contrary to the Retail Supply Tariffs and Cross Subsidy Surcharge for Financial Year-2022-23, dated.23-03-2022 and also violation of Articles of the Constitution of India and consequently direct the respondents more particularly the respondent No.6 to issue the Bill-cum-Notices to the (127) Small Scale Industries (SSI) power loom units under the category of LT-III as per the new tariff order dated.23-03-2022 forthwith and also direct the respondent No.6 to collect the arrears of the bills from the year 2016 onwards to till this date from the (127) Small Scale Industries(SSl) power loom units (cottage industries) as per the existing tariff orders;

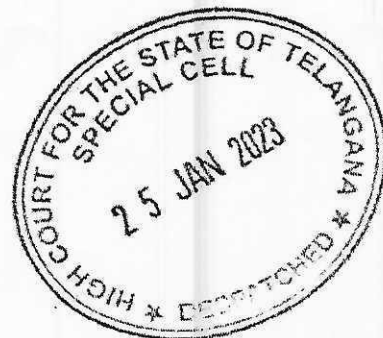

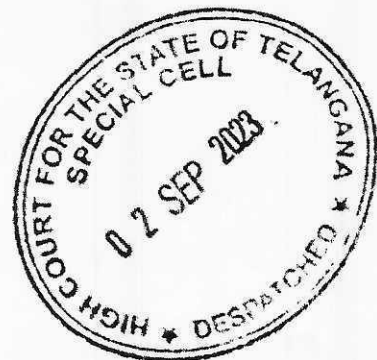
