Our Forum brings the following information to your notice to examine and make appropriate suggestions to Telangana State Electricity Board.

- 1) In many villages of Telangana the transformers are not properly fenced to protect rom electrocution. As a result there are accidents to the tune of loss of life.
- In many villages the electric supply live wires are not properly fitted and find hanging in the fields and beside the village roads.. Recently three persons died in Nizamabad District, as they came in contact with hanging live wire in an agricultural ield. (Our fact finding report is separately submitted)
- ) The Distribution system in the villages is very chaotic with low/high voltage luctuations.
- (Larlier B.R.S Government announced free electricity, to Dhobi and Barber communities, who are running small establishments. Now the field level Bill ollectors are pestering these communities to pay bills.


