3. In this connection, I am directed by the Commission to inform you the following aspects:

i) The event-wise schedule approved by the Commission is as follows:

- ii) Discoms shall publish a duly filled in **Public Notice** on 19.12.2025, in the **format enclosed**, in two (2) English newspapers, two (2) Telugu newspapers (in Telugu) and One (1) Urdu newspapers having wide circulation in their respective licensed area inviting objections/suggestions, if any, by the affected or interested person(s)/ stakeholders by 09.01.2026.
- iii) Discoms should upload their filings in their official website in .pdf and excel format in full shape as filed before TGERC for facilitating interested person(s) to view/download.
- iv) Hard copies of filings are to be made available from the date of publication of paper notification i.e., from 19.12.2025 at Corporate office and all Circle level offices. The addresses of the offices where the copies of filings can be obtained and addresses for furnishing the objections/suggestions shall be clearly indicated in the **Public Notice**.
- v) Discoms should permit the interested person(s) for perusal of filings and to take notes thereof during office hours at any of the said offices at free of charge. Person(s)/Objector(s) can also procure copy of filings on payment of charges for photocopying.
- vi) The additional/supplementary information submitted to the Commission, if any, is to be placed in Discoms' official website along the side of filings. The same is to be appended in the Hard copies of filings being made available to the interested person(s) for their perusal/purchase and to send the hardcopies of additional/supplementary information at free of cost to the person(s) who have already purchased the filings.
- vii) The Commission desires that the Discoms should simultaneously arrange responses to the Objectors as and when the Objections are received, without waiting till the due date i.e., 17.01.2026 so as to avoid any complaints of non-receipt of responses from the Objectors at the time of Public Hearing. The replies furnished against the objections/suggestions shall also be placed on Discoms website.
- viii) Further, it is to inform that the Commission intends to conduct Public Hearing in the Court Hall, TGERC, Hyderabad on 21.01.2026 (Wednesday) from 11:00 hrs onwards. The stakeholders desiring to be heard in person shall inform to Commission Secretary, TGERC before the date of Public Hearing.
