ORDER

The Co-operative Electric Supply Society Limited, Sircilla (hereinafter referred as 'CESS') a Rural Electricity Co-operative Society (RESCO) has filed an application under Section 16 of the Andhra Pradesh Electricity Reform Act, 1998 (hereinafter referred as 'Reform Act') on 11.01.2021 in the prescribed format seeking extension of exemption from grant of Licence to CESS for further period from FY 2021-22 to FY 2025-26. The applicant filed all the relevant documents and also paid application fee of Rs.30,000/- as per clause 4 of TSERC (Fee) Regulation, 2016 (No.2 of 2016).

2. The Commission vide letter ref (8) cited above, informed the CESS to obtain the recommendation of the State Government and submit the same to the Commission for taking further action in the matter in accordance with Section 13 of the Electricity Act, 2003.

3. The Government of Telangana State vide letter ref (9) cited above, has recommended for the CESS, Siricilla from the requirement of obtaining licence for (5)

years from 01.04.2021 to 31.03.2026 under Section 13 of the Electricity Act, 2003 required under Section 12 of the Electricity Act, 2003.

4. On the recommendation of the Government of Telangana State and in the public interest, the Commission is of the view, to grant further extension of the exemption granted earlier read with its subsequent extensions thereof.

5. Accordingly, in exercise of the powers under Section 13 of the Electricity Act, 2003, the Commission hereby accords to extend the exemption, which was earlier granted by it under ref (6) cited to the CESS, from the application of provisions of Section 12 of the Electricity Act, 2003, for a further period of five (5) years from 01.04.2021 to 31.03.2026 subject to and on the same terms, conditions and restrictions contained in the Licence (except that the words licence fee, which should be read as 'exemption fee' and the area of supply being eleven (11) Revenue mandals viz., Sircilla, Ellanthakunta, Musthabad, Gambhiraopet, Yellareddypet, Konaraopet, Vemulawada, Boinpally, Chendurthy, Rudrangi, Veernapally and Nallagonda & Thippaipalli villages of Kodimyal mandal) earlier granted to them under the provisions of the Reform Act vide order dated 16.06.2004.
