

3. Enquiry will be conducted and reported within 30 days.

- 4. Two persons were reinstated into service, pending enquiry.
- 5. In NPDCL the works pertaining to Agl. are covered under SPA ::PE Scheme and subsidy @ Rs.70,000/- (with DTR) and @ Rs.45,000/- without DTR. is claimed by NPDCL where as the scheme is not applicable to CESS. In CESS amounts are collected for no pole, 1 pole, 2 poles and 3 poles depending on the field requirements.
- 6. Loose lines are stringed and middle poles replaced and maintenance of AB switches carried out by replacing fixed and moving contacts.
