The applications having stood over for consideration to this day, the Commission passed the following:

ORDER

The distribution companies of Telangana (TGDISCOMs) being Southern Power Distribution Company of Telangana Limited (TGSPDCL) and Northern Power Distribution Company of Telangana Limited (TGNPDCL) (applicants) have filed an application under Section 94(2) of the Electricity Act, 2003 (Act, 2003) seeking extension of the application of the wheeling charges and wheeling losses in kind for further period upon expiry of the control period on 31.03.2024.

- 2. The applicants have sought the following prayer -
 - "... to pass orders that the existing wheeling charges and wheeling losses of last year of the 4th control period that is FY 2023-24 as determined in O.P.Nos.9 and 10 of 2019 shall continue from 01.04.2024 until the issuance of further wheeling tariff order for distribution business for 5th control period from FY 2024-25 to FY 2028-29."
- 3. The Commission by its order dated 15.03.2024 has passed the following order:
 - "12. Accordingly, the wheeling charges and losses in kind as applicable on 31.03.2024 as determined in the order dated 29.04.2020 are applicable and can be levied by applicants from 01.04.2024 onwards pending disposal of these applications finally. The applicants are directed to file the regular petitions for determination of fresh wheeling charges and losses in kind for the 5th control period being FY 2024-25 to FY 2028-29 immediately."
- 4. Subsequent to the passing of the order the petitioner in the above said O.P. has filed regular tariff petition in O.P.Nos.12 and 13 of 2024 along with Interlocutory Application in I.A.Nos.11 and 12 of 2024. The Commission by order dated 28.10.2024 has determined the fresh tariff applicable from 01.11.2024.
- 5. In view of the above, no further action is required and nothing survives for consideration. Accordingly, the Interlocutory Applications stands closed.
