ORDER:

- 1. The Principal Secretary to Government Energy Department, TS Secretariat vide Letter No.50/Budget/2014-2, dated 18-07-2014 has issued directions to TSTRANSCO to initiate action for calling tenders for 500MW solar power for the first phase, by following due procedure and Government instructions issued from time to time.
- 2. The Chairman and Managing Director/TSTRANSCO has directed CMD/TSSPDCL to float the tenders on behalf of TSSPDCL & TSNPDCL for the purchase of 500 MW in Telangana state.
- 3. The Chief General Manager (Comml & Rac), TSSPDCL, Hyderabad vide letter dated 23-08-2014 requested for approval to float tenders by TSSPDCL on behalf of TSDOCOMs as a lead procurer and for purchase of 500 MW solar power in the state of Telangana through competitive bidding route.
- 4. Erstwhile APERC sanctioned approval to float tenders by TSSPDCL on behalf of TSDISCOMs as a lead procurer and for purchase of 500 MW solar power in the state of Telangana through competitive bidding route in its Proceedings No. APERC/Engg/Secy/Dir-Engg/JD(PPP)/255/2014 Dated 22-09-2014.
- 5. The Chief General Manager (Comml & Rac), TSSPDCL, Hyderabad vide letter dated 02-02-2015 requested approval for adoption of rates of Solar energy u/s 63 of the Electricity Act, 2003 by TSSPDCL on behalf of TSDISCOMs as a lead procurer for purchasing of 520 MW solar power in the state of Telangana under competitive bidding route at rates ranging from Rs.6.45 per unit to Rs.6.90 per unit duly limiting procurement of 520 MW solar power.

6. After careful examination of transparent process of bidding done by TSSPDCL as lead procurer, the Commission hereby communicates its approval for adoption of tariff under Section 63 of Electricity Act 2003 for purchase of solar power at the tariff ranging from Rs.6.45 to Rs.6.90 per unit duly limiting procurement of 520 MW solar power.
