In the matter of determination of cross subsidy surcharge under Sections 39, 40 and 42 of the Electricity Act, 2003 for FY 2015-16.

Amendment Order.

The Commission has determined to cross subsidy surcharge by order dated 27.03.2015 to be levied by the licensees on the open access consumers in the State of Telangana. While determining the cross subsidy surcharge, the Commission made it applicable from 01.04.2015.

2. The Commission subsequently has received representations from the consumers and consumer organisations stating that the application of the cross subsidy surcharge from a retrospective date to the order is affecting them

3. Keeping in view the difficulty expressed by the consumers, the Commission suo moto amends the order dated 27.03.2015 fixed the cross subsidy surcharge as follows.

4. For the paragraph mentioned at 3.2.10 which reads as follows,
“3.2.10. The Cross Subsidy Surcharge rates determined in this Order are effective from 1st April, 2015 to 31st March, 2016.”

The following may be read which is substituted as follows:

“3.2.10. The Cross Subsidy Surcharge rates determined in this Order are effective from 1st May, 2015 to 31st March, 2016.”

5. Except to the above amendment the rest of the order dated 27.04.2015, remains unaltered. The Discoms of Telangana area are directed to give effect to the above order along with this amendment.
