**ORDER**

This petition is filed under the provisions of Section 13 of the Electricity Act, 2003 seeking renewal of the exemption from the distribution license granted by the erstwhile Andhra Pradesh Electricity Regulatory Commission by order dated 31.03.2000 in O P No. 207 of 2000 on its file under sec 16 of Andhra Pradesh Electricity Reform Act, 1998 and later renewed from time to time upto 31.03.2015.

2. The petition was taken on file of the Commission under the above said OP No. upon implementation of the AP Reorganisation Act, 2014 and consequential establishment of this Commission. The petition was listed for hearing on four occasions namely 12.08.2015, 08.09.2015, 04.11.2015 and 23.11.2015. There was

no representation on behalf of the petitioner on the last two occasions, therefore, it is deemed that the petitioner is not inclined to prosecute the petition filed by it.

3. Accordingly, the present petition is dismissed for default for non appearance of the petitioner. Any interim applications pending as such also stand dismissed for the same reason.
