**SUO-MOTO APPROVAL OF PPAs BETWEEN TSDISCOMs AND TSGENCO**

**O.P. Nos. 15 to 19 of 2021 (Suo-Moto)**

1. The Telangana State Electricity Regulatory Commission (Terms and Conditions for Determination of Generation Tariff) Regulations, 2019 [Regulation No. 1 of 2019] and Andhra Pradesh Electricity Regulatory Commission (Terms and Conditions for Determination of Tariff for Wheeling and Retail Sale of Electricity) Regulation, 2005 [Regulation No. 4 of 2005] adopted vide Telangana State Electricity Regulatory Commission (Adoption) Regulation [Regulation No. 1 of 2014] provide for approval of Power Purchase Agreements (PPAs) entered between Generating Entities and the Distribution Licensees.
2. TSDISCOMs viz., Southern Power Company of Telangana Limited (TSSPDCL) and Northern Power Company of Telangana Limited (TSNPDCL), have submitted before the Telangana State Electricity Regulatory Commission (TSERC) the proposal for consent of PPAs entered between the TSDISCOMs and TSGENCO. These PPAs have been taken on record by the Commission in O.P. Nos. 15 to 19 of 2021.
3. Copies of the PPAs referred are uploaded on the Commission's website [www.tserc.gov.in](http://www.tserc.gov.in). Based on the submissions made by TSDISCOMs, the Commission has initiated the *Suo-Moto* proceeding for approval of PPAs entered between TSDISCOMs and TSGENCO. Suggestions/ objections/ comments in the subject matter are invited from all stakeholders and public at large, so as to reach the following address on or before 18.06.2021 by 5.00 P.M.
