

**Petition filed on behalf of TGDISCOMs Under Section 86 (1) (b) of  
Electricity Act 2003**

The applicant most respectfully submits:

1. The present Petition is being filed by the Distribution Companies of Telangana i.e., TGDISCOMs (TGSPDCL & TGNPDCL) **Under Section 86 (1) (b) of Electricity Act 2003** (hereinafter referred as 'the Act') seeking consent/approval of the Hon'ble Commission for the draft 2<sup>nd</sup> amendment to

31.03.2029 and RTS-B (62.5 MW) for a period from 01.04.2024 to 03.06.2024.

Factual Back Ground:

- (i) Common PPA dated 22.12.2009 was entered by erstwhile APGENCO with the four DISCOMS of united Andhra Pradesh for all Thermal and Hydel Stations which were commissioned between 1956 to 2004 and it has been in force for the period from 01.04.2006 to 31.03.2019.
- (ii) After expiry of Common PPA, another PPA was entered on 17.09.2019 between TSGENCO now TGGENCO and TSDISCOMs now TGDISCOMS for 100% sale of power to TSDISCOMs now TGDISCOMs for all Thermal and Hydel Stations which were commissioned between 1956 to 2004 containing Terms & Conditions as per provisions of TSERC now TGERC Regulations.
- (iii) The Hon'ble TSERC now TGERC after conducting public hearing through Video Conference by order dated 06.08.2021 in O.P.No.16 of 2021 accorded consent to the PPA dated 17.09.2019 (Suo-Moto approval) subject to amendments in certain clauses and Articles of the PPA.
- (iv) Accordingly, the PPA was amended on 22.12.2021 for Thermal and Hydel Stations (commissioned between 1956 to 2004) by carrying out the modifications as per order of TSERC.
- (v) The validity of the PPA of Thermal Stations of KTPS-V (500 MW) and RTS-B (62.5 MW) got expired on 31.03.2024.
- (vi) TSGENCO now TGGENCO proposed 2<sup>nd</sup> Amendment for extension of Power Purchase Agreement of KTPS-V upto 31.03.2029 (5 years) and RTS-B for a period one year i.e., upto 31.03.2025.
- (vii) By considering ever growing peak demand, energy requirement, present installed capacity, capacity additions in progress, retirement of thermal units and 5% spinning reserve, there is a requirement of additional power projects based on Thermal, Hydro and Renewable mix to derive timely benefits.
- (viii) Long Term PPAs are important part of TSDISCOMS now TGDISCOMS power purchase plan. TSDISCOMS now TGDISCOMS enter into long term PPA with TSGENCO now TGGENCO for a period of 25 years to meet their bulk power requirement and to avoid price volatility.
- (ix) The power generated from these Power Projects will help in bridging the gap between electrical power demand and available power in the

present and future agricultural power demand as well as other developmental activities in the Telangana State.

- (xi) Therefore, it was opined that the need for procurement of power by TGDISCOMS from TGGENCO Power Projects through the envisaged PPAs is justified.

- (xii) As per the Article 6 of the PPA, the validity of PPA can be extended on mutual consent of the parties with prior consent of TSERC.

“..... Article 6 (Duration of the Agreement) of PPA, “agreement may be extended, renewed, amended or replaced by another agreement on or before the expiry of this agreement, on such terms and for such further period of time as the parties may mutually agree subject to prior consent of TSERC” .....

- (xiii) Further, As per the Article 2 of the PPA, dated 17.09.2019 for which the Hon'ble Commission has accorded consent vide OP.No.16 of 2021 vide order dated 06.08.2021

## 2.1 Power Supplies by TSGENCO:

*From and after the date of the effectiveness of this Agreement, TSGENCO shall make available and deliver, and TSDISCOMS shall purchase for the consideration set forth in this Agreement, all the Declared Capacity and Net Electrical Energy generated by the Power Stations, (both Thermal & Hydel) subject to such Dispatch Instruction as may be in effect. If DISCOMs continue to purchase power even after the expiry of this agreement provided that this PPA is not renewed, in such cases the provisions of this PPA shall be applicable till this agreement is renewed, extended or replaced.*

- (xiv) It is to submit that as per the Article 2.1 of the consented PPA DISCOMs have continued to purchase power from the said stations from 01.04.2024 onwards
- (xv) KTPS-V (500 MW) and RTS-B (62.5 MW) are the TGGENCO Thermal stations commissioned on 28.02.1998 and 17.10.1971 respectively and completed more than 25 years of service.
- (xvi) In view of the above, it was proposed to amend PPA dated 17.09.2019. Accordingly, draft amendment dated 28.03.2024 was proposed extending the Power Purchase Agreements of TSGENCO now TGGENCO Thermal Stations, KTPS-V (500 MW) for a period of 5 years i.e. up to 31.03.2029 and RTS-B (62.5 MW) for a period of one year i.e., up to 31.03.2025.

In this regard, a letter dated 30.03.2024 has been addressed to the Hon'ble TSERC requesting to accord consent/approval for the draft 2<sup>nd</sup> amendment to PPA for extending the period of 2 Nos. TSGENCO now TGGENCO Thermal Stations KTPS-V and RTS-B.


3. The Hon'ble TSERC vide letter dated 24.04.2024 has returned the request of TSDISCOMS now TGDISCOMS for according consent for draft 2<sup>nd</sup> amendment to PPA dated 28.03.2024 and directed the Chairman and Managing Directors of TSDISCOMS now TGDISCOMS to file a proper petition for seeking consent. In compliance with the said direction the present petition is being filed.
4. It is to submit that there is an inordinate delay in filing this petition as RTS-B station has served more than 50 years and in view of frequent technical issues there arose a necessity to take a decision on the further continuation of RTS-B station or not.
5. Meanwhile, the RTS-B station was under shutdown from 04.06.2024 due to technical issues and generation could not be restored till date.
6. In view of the above, it is prayed to consider the extension of PPA for RTS-B station for a period from 01.04.2024 up to 03.06.2024 only as against the period mentioned in the draft PPA (i.e., one year up to 31.03.2025) submitted to the Hon'ble Commission vide letter dated 30.03.2024 seeking consent.
7. Further, It is submitted that TSGENCO is renamed as TGGENCO and TSDISCOMS are renamed as TGDISCOMS. Hence PPAs shall have to be read as TGGENCO and TGDISCOMS, where ever they are referred as TSGENCO and TSDISCOM.

**PRAYER:**

Hence the Hon'ble Commission may be pleased to:

- Accord consent/approval to amend the PPA dated 17.09.2019 between TSDISCOMS and TSGENCO Thermal Stations, to extend

- May pass such other order or orders, as the Hon'ble Commission may deem fit and proper in the facts and circumstances of the case.


