#### REGULATION No.1 of 2022

#### Preamble:

The Commission, soon after its formation, through its notified Regulation No.1 of 2014 has adopted previously subsisting regulations and its amendments thereof which includes Regulation No.4 of 2005 and its amendments thereof being 'Terms and Conditions for Determination of Tariff for Wheeling and Retail Sale of Electricity' (hereinafter referred to as Principal Regulation) notified in the Gazette dated 14.11.2005 and its first amendment notified in the Gazette dated 07.03.2014. The Commission notices that there had been instances wherein the distribution licensee had failed in filing the petitions within the stipulated timelines as per the terms of the Principal Regulation and the Principal Regulation does not provide for consequences of delay in filing the proposals with the Commission.

In exercise of powers conferred on it under clause (b) of Section 61read withclause (zp) of sub-section (2) of Section 181 of the Electricity Act, 2003 (Central Act No.36 of 2003) and all other powers enabling it in this behalf, and after previous publication, the Telangana State Electricity Regulatory Commission hereby makes the following Regulation to amend the Principal Regulation, namely: -.

#### 1. Short title, Extent and Commencement

 This Regulation shall be called the Telangana State Electricity Regulatory Commission (Terms and Conditions for Determination of Tariff for Wheeling and Retail Sale of Electricity) SecondAmendment Regulation, 2022.

- 2. This Regulation shall extend to the whole of Telangana State.
- 3. This Regulation shall come into force on the date of its publication in the Telangana Gazette.
- 4. After clause 15.1 of the Principal Regulation, the following clause shall be added.
  - "15.2 In case of any delay in submission of filings as required under this Regulation, the rate of return on equity shall be reduced by 0.5% per month or part thereof."
