TELANGANA STATE ELECTRICITY REGULATORY COMMISSION (Fee) First Amendment Regulation, 2022

REGULATION No.2 of 2022

Preamble:

The Commission had notified the Regulation No.2 of 2016 being the Telangana State Electricity Regulatory Commission (Fee) Regulation, 2016(hereinafter referred to as 'Principal Regulation') in the Telangana Gazette dated 28.03.2016. The Commission notices that there had beeh instances where some of the regulated utilities such as generating companies and licensees had failed in filing the petitions viz., Aggregate Revenue Requirement (ARR)/ Tariff/Annual Performance/Mid-Term Review/Additional Surcharge/Resource Plan/State Electricity Plan/Business Plan/ Capital Investment Plan, within the stipulated timelines as per the provisions of their relevant regulations and the Principal Regulation does not provide for consequences of delay in filing the proposals with the Commission.

Therefore, in exercise of powers conferred on it under sub-clause (g) of clause (1) of Section 86 read with clause (zp) of sub-section (2) of Section 181 of the Electricity Act, 2003 (Central Act No.36 of 2003) and all other powers enabling it in this behalf, and after previous publication, the Telangana State Electricity Regulatory Commission hereby makes the following Regulation to amend the Principal Regulation, namely: -1.

- Short title, Extent and and Commencement
- This Regulation shall be called the Telangana State Electricity Regulatory Commission (Fee) First Amendment 1. 2.
- This Regulation shall extend to the whole of Telangana State.

- 3. The Regulation shall come into force on the date of its publication in the Telangana Gazette.
- 4. After the clause 4 (3) (b) of the Principal Regulation the following clause shall be added
 - (c) The penal fee that is attracted in case of the licensee or generating company not complying with the provisions of other regulations on the specific topics mentioned in the table below shall be required to pay the penal fee as shown in the opposite column on each of the petition separately whenever it is filed.
 - Aggregate Revenue Requirement & Tariff/Multi Year Tariff Petition.
 - Annual Performance Review Petition.
 - Mid-Term Review Petition/True up Petition.
 - Additional Surcharge Petition.
 - Resource Plan Petition.
 - 6. State Electricity Plan Petition.
 - 7. Business Plan Petition.
 - Capital Investment plan Petition by the generating companies, licensees and State Load Despatch Centre.

Rs.5,000/- per day for the first 30 days beyond the specified date.

After 30 days, Rs.1,50,000/plus Rs.10,000/- per day till submission of petition.
