

**TELANGANA ELECTRICITY REGULATORY COMMISSION**  
**(TERMS AND CONDITIONS OF OPEN ACCESS) FIRST AMENDMENT**  
**REGULATION, 2026**

**Regulation No.2 of 2026**

**No: TGERC/Secy/D.No: 65/2026, Dt: 24.01.2026**

The Telangana Electricity Regulatory Commission (Terms and Conditions of Open Access), Regulation, 2024 (hereinafter referred to as “TGERC Regulation No.1 of 2024” or “Principal Regulation”) was notified on 18.03.2024, in the (Part-II) of the Extraordinary Telangana Gazette.

Whereas Clause No. 33.5 of the Regulation No. 1 of 2024 provides for issuance of Renewable Energy Certificates (RECs) to the extent of the unutilised banked quantum of energy to the GEOA consumer.

And whereas based on clarification issued by NLDC on issuance of RECs to the green energy open access (GEOA) generator for the unutilised energy/surplus energy injected in the month, TGSLLDC has approached the Commission for amendment of the Regulation 1 of 2024 to enable issuance of the RECs to Renewable Energy Generators for the unutilised banked quantum of energy, and also as per the clause 7.2.(e) of the “CERC Procedure for Implementation of REC Mechanism 2024” dated 07.03.2024 issued by the Grid Controller of India.

Accordingly, in exercise of the powers conferred by Sections 181(1) read with Sections 42(2), 42(4), 39(2)(d)(ii) and 40(c)(ii) of the Electricity Act, 2003 (36 of 2003) and all other powers enabling it in that behalf, the Telangana Electricity Regulatory Commission hereby makes this first amendment Regulation, 2026 to the TGERC Regulation No. 1 of 2024 namely: -

**1. Short title, extent and commencement:**

- a) This Regulation shall be called the Telangana Electricity Regulatory Commission (First Amendment to Regulation
- b) 1 of 2024 being Terms and Conditions of Open Access Regulation, 2024), Regulation, 2026.
- c) This Regulation shall extend to whole of Telangana State.
- d) This Regulation shall come into force on the date of its publication in the Telangana Gazette.

**2. Clause 14.11 of Principal Regulation shall be modified as below:**

“14.11. Any energy injected into the licensee’s network from the date of grant of GEOA till the date of submission of agreement for wheeling, the applicant is not entitled for payment of energy charges and the energy injected shall be treated as inadvertent power.”

**3. Provision in clause 33.5 of Principal Regulation shall be modified as below:**

“Provided that, Renewable Energy Generating Station would be entitled to Renewable Energy Certificates (RECs) to that extent.”
