Errata for ARR and Wheeling Tariffs Order dated 28.10.2024

While going through the Orders passed by the Commission in O.P.No. 12 of 2024 and O.P.No. 13 of 2024 dated 28.10.2024, in respect of ARR and Wheeling Tariffs for TGSPDCL and TGNPDCL for FY 2024-25 to FY 2028-29, the Commission found that there were certain small errors at para 4.13.8, Appendix-A and Appendix-B, which are purely inadvertent typo errors.

'7. The other conditions applicable for levy and collection of Wheeling Tariff shall be as per the provisions of the Regulation No. 1 of 2024 (Terms and Conditions of Open Access) Regulation, 2024 and its amendments.'
