2. **Price:**

- Price is to be quoted in **Annexure - A (enclosed)**. You are requested to furnish **Lumpsum amount** for AMC of the equipment mentioned in **Annexure B** in sealed cover.
- Individual items in **Annexure B** should also be quoted.
- Price quoted should include the cost of supporting the systems under warranty shall include labour. Price for systems not under warranty shall include charges of resident engineer, labour and material.
- Price should include transportation charges for maintaining systems located at residences.
- Quotations should be for all the equipment mentioned in Annexure A. **Conditional quotations will not be accepted.**

3. **Taxes and Duties:**

The prices quoted shall be inclusive of all taxes. TSERC is not liable to pay any additional amounts towards taxes and duties either now or in future. TSERC will recover the statutory taxes and duties, as applicable, if levied at a later date, either in full or in part from the securities provided by you against this order.

4. **Deduction of statutory taxes & duties:**

Taxes / duties will be deducted at source as applicable.

5. Scope of Work

- Maintenance & service of all Desktops, Laptops, Projectors, Switches & Network Equipment at various locations at the office of the TSERC, Hyderabad and residences of Chairman & Members.
- Maintenance & service of system software and other software packages and customization of systems as and when required.
- Maintenance of Switches and Network equipment.
- Integration of the complete system and testing of the complete system as and when required.
- Maintenance of system software such as Installation & configuration and Administration of Operating System (XP, Vista, Win7, etc), Antivirus Maintenance.
- Installation of Antivirus in all desktops and further updation (as and when required). Antivirus license will be provided by this office. It is the responsibility of facilitator to guard the systems against virus infections. Downtime due to virus, spam, and spy ware is attributable to facilitator.
- All the equipment except those under warranty will be covered under comprehensive AMC.
- Preventive maintenance for all equipment's is to be done quarterly.
- Standby machine shall be provided, if downtime is more than 2 days.
- The facilitator should have experience in terminating Leased / Broadband lines in Router / Firewall.

6. Down Time:

Down Time is defined as the time for which the systems and or services running on it are said to be not available to the users in part or full due to any non - functioning, repairs / problems etc. The penalty will be counted from the time problem is reported to facilitator till problem is solved / rectified to the satisfaction of user. Penalty shall be applicable once the admissible down time is crossed. The admissible down time is as follows:

Maximum Admissible Downtime:

A) Clients and Peripherals - Maximum 20 **office hours** calculated over
a Period of Three months

Note: In case of intermittent failures and repetitive problems due to improper diagnosis or repair, the system, will be treated as continuously down from the time of first fault reporting.

7. **The facilitator shall provide maintenance service against all risks, except those risks covered by Force Majeure conditions as follows:**

- i. Preventive maintenance and carrying out the necessary repairs and fittings of replacement parts wherever applicable. Replaced parts become the property of facilitator. Preventive maintenance shall not be attended during run / office time. However preventive maintenance which does not affect normal operation can be attended during run time with the permission of user. Preventive maintenance shall be carried out at least once in a quarter.
- ii. The bidder is required to maintain adequate stocks of spares to meet the requirements. TSERC, reserves the right to verify the stocks at any point of time.
- iii. Wherever a component has to be replaced, it shall be replaced with a component of the same make and configuration. In case the component of same make and configuration is not available, the replacement shall conform to open standards and shall be of a higher configuration specifically approved by TSERC.
- iv. The facilitator, may if so advised technically, get a dysfunctional hardware component repaired in lieu of its replacement, subject to ensuring the overall compliance of the requirement of up time.
- v. The facilitator shall ensure that all the replacements and components used in the process of restoring systems are genuine and original.
- vi. The essence of the hardware maintenance contract is to ensure that all the components of hardware work perfectly in unison and deliver rated performance during the period covered by the agreement between the facilitator and TSERC and that the systems uptime is up to the standards prescribed.

8. **Access to the Equipment:**

TSERC shall give the facilitator required access to the equipment to enable maintenance services.

9. Maintenance of Call Record:

A record is to be maintained for entering the details of equipment failure including the nature of failure, date and time of booking of the complaint. When the call comes up, it would be recorded and signed by the service engineer of facilitator and TSERC representative. Format for keeping this record will be as per the Annexure-C. Periodical reviews will be taken by TSERC from time to time. The quarterly bill should include the call records during the quarter.

10. Pre- qualifications of the tenders:

The bidder shall possess the following minimum qualifications:

- a) The bidder shall have at least 3 years of experience as on bid calling date in all of the following areas.
 - i. Maintenance of desktops and Laptops,.
 - ii. Maintenance of Projectors and Scanners.
 - iii. Maintenance of network devices like I/Os, hubs, switches & network cabling, routers, firewall, and modems etc.
 - iv. Maintenance of system software such as Installation & configuration and Administration of Windows OS (XP, Vista, Win7, 2012 server etc., and Antivirus Maintenance.
 - v. Handling of various services running on them.
 - vi. Handling virus through anti-virus tools.
 - vii. Handling Security issues.
 - viii. Experience in providing the “services” defined in the scope of this tender.
- b) Bidder should have experience in maintaining at least three site/contract having minimum 50 PCs.
- c) The bidder should have registered H.O/Branch office at Hyderabad and running for the last 3 years as on bid calling date. Service tax registration certificate should be submitted.
- d) The bidder shall enclose documentary proof of his qualifications to the tender.

Note: Relevant documents in support of above should be furnished.

11. **Evaluation of bid:**

- During the evaluation of bid TSERC may ask vendor(s) for additional information, visit to vendors site and/or arrange discussions with their professional, technical faculties to verify claims made in the bid.
- Final choice of firm to execute the contract shall be made on the basis of appropriateness of the services offered, capability of bidder to execute and service the contract over the entire contract period.
- TSERC reserves the right to accept or reject all of the tenders received without assigning any reasons there for.

12. **Jurisdiction:**

All and any disputes or differences arising out of or touching this contract will be decided by the Courts of Tribunals situated in Purchaser's Headquarters only. No suit or other legal proceedings will be instituted elsewhere.
